

## TERMS OF SERVICE

### SPOILTHEPRINCESS.COM TERMS OF SERVICE AGREEMENT

By accessing the SPOILTHEPRINCESS.COM website (the “Website”), including through a mobile application, you agree to be bound by these Terms of Use (this “Agreement”), whether or not you register as a member of SPOILTHEPRINCESS.COM. If you wish to visit the Website or to become a member and make use of the SPOILTHEPRINCESS.COM service (the “Service”), please read this Agreement.

The Terms of Use are as set forth in English. You should not rely on any non-English translation. Refer to the English Terms in the event of any discrepancies or inconsistencies.

If you do not accept and agree to be bound by all of the terms and conditions of this Agreement or you do not meet or comply with its provisions, do not use the Website or the Service.

Please review this Agreement carefully, which describes how Disputes (defined below) will be resolved between us, and that no class actions may be brought under this Agreement.

**Binding Agreement** This Agreement is an electronic contract that sets out the legally binding terms you must accept to use the Website and to become a “Member.” For purposes of this Agreement, the term “Member” means a person who provides information to the Company on the Website to participate in the Service in any manner. This Agreement may be modified by SPOILTHEPRINCESS.COM in its sole discretion at any time, and any such modifications will be posted on the Website. Your continued use of the Website or the Services after the posting of modifications to this Agreement will constitute your acceptance of such revisions. Any proceeding to enforce this arbitration agreement, including any proceeding to confirm, modify, or vacate an arbitration award, may be brought in any court of competent jurisdiction. In the event that this arbitration agreement is for any reason held to be unenforceable, any litigation against SPOILTHEPRINCESS.COM (except for small-claims court actions) may be commenced only in the federal or state courts located in Clark County, Nevada or in the territorial boundaries of England and Wales. You hereby irrevocably consent to the jurisdiction of those courts for such purposes. Regardless of any

statute or law to the contrary, and to the maximum extent permitted by applicable law, any Dispute must be filed within one (1) year after the date in which the incident giving rise to the Dispute occurred. Failure to file an arbitration claim as described above within the applicable limitations period constitutes a waiver of such claim and serves as complete bar to any claim based on any Dispute. This Agreement, and any Dispute between you and SPOILTHEPRINCESS.COM, shall be governed by the laws of the state of Nevada, if plaintiff resides in the contiguous boundaries of the United States without regard to principles of conflicts of law, provided that this arbitration agreement shall be governed by the Federal Arbitration Act. If you access the Website or use the Service from outside the United States, all disputes will be resolved under the jurisdiction of England and Wales, without regard to principles of conflicts of law, provided that this arbitration agreement shall be governed under the United Kingdom Arbitration Act of 1996.
